

FACILITY MEMBERSHIP

SPECIAL CONDITIONS

VERSION 1.1



These terms and conditions (**Facility Membership Special Conditions**) apply to people who wish to access Unigym Facilities (with the exception of the Sports Hall), as well as Unigym Activities and Independent Activities, on a casual basis.

1. Fees and charges

- 1.1 In order to take out Facility Membership, the fee identified on the Price List is applicable (**Up Front Fee**).
- 1.2 In addition to the Up Front Fee, a charge will apply each time you access the Facilities regardless of whether you are a UTAS staff member or student (**Access Charge**). The amount of the Access Charge will depend on the Facility that you propose to use or the Activity you engage in. The prices are set out on the Price List.
- 1.3 Unigym may increase the Up Front Fee or Access Charges at its discretion, however Facility Members will be notified of any impending price increases in accordance with the General Terms and Conditions.
- 1.4 Only UTAS staff and students are entitled to discounted Facility Memberships.

2. Application for membership

- 2.1 If you are eligible for a discounted Facility Membership, you must present evidence of your status when you apply for membership.
- 2.2 Your membership will be valid for the term outlined on your application form.

3. Health Screen

- 3.1 If your Facility Membership expires and you wish to take up another Facility Membership, you will be required to complete a fresh Health Screen.
- 3.2 Completing a Health Screen and submitting it to Unigym is a pre-condition to your application for a new Facility Membership being processed.

4. Independent Providers

- 4.1 Unigym is unable to agree on behalf of Independent Providers that you can participate in Independent Activities which they offer from the Facilities.
- 4.2 Where the activity you propose to participate in is an Independent Activity you should ensure that you seek the agreement of the Independent Provider that they will agree to your participation in the relevant Independent Activity before you apply for Facility Membership.
- 4.3 Independent Providers may impose conditions on the manner in which the relevant Facility is used by you where you participate on an Independent Activity. If so, you must comply with those conditions when using the Facility.

5. Your ability to cancel you Facility Membership before the end of term

- 5.1 You may cancel your Facility Membership prior to its expiry by providing Unigym with written notice. A refund will apply if a change referred to in clause 1.3 of the General Conditions has occurred and Unigym has formed the view (based on information provided to you) that it is not possible for you to enjoy the membership benefits that you have enjoyed before the change.
- 5.2 Upgrading your membership will not entitle you to a refund.

6. Transfer of membership

- 6.1 Facility Membership is not transferable.

7. Time Stoppage

- 7.1 Time stoppage is not available for Facility Memberships.
